



# How clearly were course learning goals and objectives communicated to you?





## How effectively was class time used to help you learn?





# How effectively did out-of-class work (assignments, readings, practice, etc.) help you learn?





## How available was the instructor to provide help when needed (in person, by email, office hours, etc.)?





# How likely would you be to recommend this course with this instructor?





## How much did the instructor motivate you to do your best work?





# How much did the instructor emphasize student learning and development?





## Please describe 2 or 3 activities, assignments, readings, etc. from which you learned the most:

#### Comments

The Unessay was a very enjoyable and easy assignment. I liked that we were able to do whatever we wanted with it and be as creative as possible. All of our readings, although some very lengthy, I enjoyed because of the different topics they covered.

In–Class workshops were great hands on but relevant activities which allowed the application of skills as learned in class. The workshops, such as the day spent in the Lilly Library, were fun, engaging, and educational. Another activity which was beneficial to me as a student was the Unessay. Unlike a traditional final exam or project, this assignment allowed for student to relay what we learned throughout the semester and interpret and present it in our own way. Rather than regurgitating information, the instructor pushed for the understanding of the topics discussed in class through creative means which I and other students greatly appreciated.

Readings before every class diversify your knowledge of the topic, usually from an opinion on which you could disagree with, so that discussion can occur in class, with topics ranging from fake science to conspiracy theorists. The Piece of BS assignment allowed us to replicate (but NOT disseminate) a piece of media which contributes to a problem of political influence and misinformation with media consumption.

Conspiracy theories and our guest speaker on the paranormal was able to open my eyes up and learn more I hadn't known in the past.

Searching for fake news and the art of how to search for untruthfulness.

The week on Objectivity was something that was very interesting to me. The way that news sources try and be as middle ground as possible without bringing any personal opinions into the matter. The paranormal and photography was an amazing week. I loved the guest speaker that he had brought in to speak to us. It was a very enjoyable week of class. It was interesting going in depth on fake news towards the beginning of the semester. I enjoyed when we spent time in class going through a explaining why these were fake news, it was awesome.

I believe that reading a wide variety of authors and mediums gave us a wholistic scope of issues we discuss. The bullshit inventory assignment was especially useful, for it truly made me more aware of the information around me.

I really learned from the documentaries we watched, as well as the lectures/talking time we had during class. Everything we did made me think in one way or another, and I feel that I've gotten way more out of this class than I thought I would (not only did I establish my own worldviews about things, but I also feel like I'm more adequately prepared for facing real life/having the confidence I am actively working on.)

I believe that the bullshit inventory was a good assignment to motivate introspection on the course topic. I also found the in–class workshops to be very conducive to learning especially because I could get instant feedback on the assignment and have a free discussion.

I enjoy the workshops that we do in class as well as group discussions over that specific topic for the week/day.

I learned from going to see the old newspapers. I also learned a lot from the climate change deniers documentary and the guest speaker that was brought in.

I think I learned the most from the Bullshit pieces we had to do because they required you to inform yourself about the topic and become involved with it. It makes you see the reason behind why people like to create bullshit articles. Am I allowed to swear on this? I hope so.


No I think I had a good instructor

Classes like this are engaging and fun while still allowing you to learn. This topic is especially important in today's political climate.



The instructor created an environment that was conducive to learning.





### Describe the instructor's strengths. Additionally, how could the instructor improve?

Topics such as the breakdown of a fact check and the definition of misinformation were most meaningful and resonated the most for me. A less useful topic may be that of Paranormal activity. The topic was entertaining and fun and there were things to be learned from it, but its takeaways were minimal compared to other units discussed in class.

The range of topic covering all aspects of fake news was enriching and allowed perspectives I hadn't thought of before. Some readings were long, and I definitely didn't spend much time on them though.

The courses strengths were meaningful because they were able to keep me engaged and interested to actually read the articles sent to me by Jordan.

The course itself helped me to understand the difference between real and fake news as well as why people believe what they do. This will help with my everyday decision making in the future.

The units on stuff like climate change and how to address fake news when we see it was helpful. The larger philosophical discussions, like how science is created by society, sometimes wasn't given enough time so it went over my head.

## What did you learn from this class?

#### Comments
